- 2004- GAO concluded that RDI rulemaking did not violate rulemaking moratorium (PL 104-208)
- Wenker Memo and IM 2010-016 are still active, which established a moratorium on the use of RDI for claimed R.S. 2477 rights-of-way. BLM must rescind these policies before it can process RDI applications for R.S. 2477 rights-of-way

- 1. The Wenker memo, as clarified by BLM Instruction Memorandum No. 2010-016, was intended to temporarily suspend the BLM's work on processing or reviewing claimed R.S. 2477 rights-of-ways, but was not intended to be a final policy decision.
- 2. Section 315 of FLPMA authorizes the Secretary to issue disclaimers of interest in certain situations. The decision by the Director to rescind the Wenker Memo and BLM Instruction Memorandum No. 2010-016 is consistent with all Departmental regulations and BLM policy.
- 3. Any applications submitted to the BLM for recordable disclaimers of interest regarding claimed R.S. 2477 rights-of-way must comply with the requirements of the applicable regulations at 43 C.F.R. Subpart 1864. Such requirements include the submission of an application and information sufficient to support a determination by the BLM that the claimed right-of-way has vested pursuant to applicable law. The BLM will publish notice of applications for recordable disclaimers of interest that it is reviewing in the Federal Register and make such applications and submitted information available for public review.
- 4. Recordable disclaimers of interest are one of many tools that the BLM may consider using when working with state and local governments to resolve long-standing issues related to the use, maintenance, and improvement of historic rights-of-way on public lands.

Such requirements include the submission of an application and information sufficient to support a determination by the BLM that the claimed right-of-way has vested pursuant to applicable law. The BLM will publish notice of applications for recordable disclaimers of interest that it is reviewing in the Federal Register and make such applications and submitted information available for public review.
- 4. Recordable disclaimers of interest are one of many tools that the BLM may consider using when working with state and local governments to resolve long-standing issues related to the use, maintenance, and improvement of historic rights-of-way on public lands.




